

# Commission Rules:

\*By contacting the artist, you have agreed you have read the artist's TOS and that you are 18+.

I will not be carding, or asking to show proof. I work off old internet terms. If you:

- Reach out to me for a service,
- Aren't acting like you are below the requested age
- Agree/imply you are of age
- Have the money to do business with

I will treat you like an adult, and I'll most likely do business with you.

## TOS can change at any time.

To make sure the TOS is relevant, it may change at any time. So please check for any changes that may affect you. There may be other areas that need to be added or removed to meet the needs of the artist, and improve the service for the commissioner.

---

## Commissions are placed through email, and (major) communication is through email.

Any commission request not sent to the appropriate email will NOT be acknowledged. Accepted orders will be responded to by email. Denial emails are also sent. A receipt will be emailed to you as well once payment has been completed.

After initial emails and payments have been done, some options for communication can be extended to Instant Messengers. Any major changes must be documented in email. If other communications are accepted, pictures can be delivered Via IM, but will always be delivered via email.

Artist is allowed to turn down IM options.

## Payment first; No Refunds

Payment is accepted via [Stripe](#) (primary), [Segpay](#), [PayPal](#), [Zelle](#), [Cash](#), or [Cryptocurrency](#).

Prices are subject to change at any time. Any applicable fees will be communicated at the time of your order.

Once your order is accepted, you will receive a payment invoice or instructions to the email provided. Your order will not begin until payment is confirmed. Payment must be completed within **5 days** of receiving invoice or payment instructions. If payment is not made within 5 days, your order will be canceled and you will need to resubmit.

**Stripe & Segpay:** You will receive a secure invoice link to your provided email. No account is required — any valid email works.

**PayPal:** Please provide a valid PayPal-connected email so an invoice can be sent.

**Zelle & Cash:** Available if physically able to arrange. Contact the artist for details.

**Cryptocurrency:** The following coins are accepted:

- **XRP**
- **USDT**
- **ETH**
- **BTC**

Once your order is accepted, confirm which coin you will be sending. Wallet address will then be provided via email. Payment is only confirmed once receipt is verified by the artist on their end. Please ensure you are sending the correct coin to the correct wallet — incorrect transfers cannot be recovered, and the order will not be considered paid. Please understand the risks.

Please remember to send the correct cryptocurrencies to their respective wallets! They do not share the same home! If a tag is needed (e.g. XRP), please make sure you have the correct tags — tags ensure your money will reach the artist and not get lost.

#### **When selecting Crypto:**

- Please remember to send the correct cryptocurrencies to their respective wallets! They **do not** share the same home!
- If a tag is needed (ex: *XRP*), please make sure you have the **correct tags!**
- Tags ensure your money will reach me and not get lost.
- Sending incorrect coins to the wrong wallets will get lost, and the picture will not be paid for.

#### **Please understand the risks!**

Wallet Example:

**x ETH coins >>> XRP wallet**

**✓ ETH coins >>> ETH wallet**

Payment is **non-refundable**. Even if work has not physically begun, planning, research, and preparation are considered part of the commission process. Please be certain before submitting. If paid and you refuse the finished order, you will not receive a refund or the image. There will be no exceptions.

Please make sure you are financially stable to commission me. I will not grant a refund because you did not plan properly. You are making this choice — I will still be here later. **There will be no refunds.**

*Final delivery is considered complete upon the finished file being sent to the client's provided email address.*

## Payment Plan Policy and Fees

Payment plans are only available for certain commission types at certain starting prices. As with any payment plan, fees apply to help offset the inconvenience to the artist — this includes overhead, processing, and platform fees.

Depending on the work, payment plans can range from 2–6 months. A fee will be applied each month depending on the plan, price, and project.

Although this is an option, **payment plans can be denied.**

---

## Changes to Commission requests can be denied or accepted.

Changes to requests can be denied or accepted. Additional fees will be added if you want changes made once payment is received. Your drawing will be halted until payment for changes is made. If payment for changes is not made within 72 hours (unless communication states otherwise), your picture will be continued without changes and payment for changes will not be accepted.

If you did not provide proper references for your picture, I have the right to decline your request or give you what I can work with.

If the commissioner is rude or disrespectful, I will not tolerate it, will stop work, and deliver whatever was completed at that point. No changes will be made, additional change payments will not be accepted, and you will be placed on the blacklist. All future commission requests will be automatically denied.

**Completed Pictures:** Once a picture is done, you are allowed **2 free small changes within 48 hours** of the completed picture delivery. After that, additional revision fees apply based on the size of the request.

This does not apply if you are blacklisted or not in good standing with the artist.

---

## Completed Pictures: Once a picture is done, you are allowed 2 free small changes within 48 hours of the completed picture time.

After that, based on revision request size, an additional fee will be requested.

This does not apply if you are blacklisted, or aren't in good standing with the artist.

---

## Please have patience.

Each drawing takes time. There will be communication and you will see current progress. Depending on your selected commission type, you will have multiple opportunities to give feedback and make changes.

## Rush Orders

## Include any image references

Character art, clothes, poses, mood, Backgrounds, hair — these all help me, and helps cut down the wait time.

---

## I am allowed to turn down orders.

Please be understanding and respectful. SFW and Ecchi requests are allowed, however; I am allowed to turn down either of them for whatever reason.

---

## Image ownership is not passed down.

Commissions are paid request pictures only. Image ownership is not passed down or granted to the client. Please do not use the image for branding or any purpose that requires ownership.

With the rise of NFTs and AI, I want to make it clear: pictures are not owned by the client. Unless a separate agreement has been made and the necessary fees paid, I, the artist, retain full ownership. This includes limited private pictures — once the agreed private time has passed, I have full right to post or edit the picture.

The client is allowed to post the image but **cannot use it for monetary gain**. This also includes no AI training on pictures I have created.

---

## Private Picture policy and fees

You can request private pictures for projects or gifts. Private pictures carry an additional fee noted on the commission page. You can refresh the private period (up to 36 months total) if the original time was not enough.

Due to the nature of this work, I cannot promise 100% private images, as I do ask for feedback from other artists. This policy specifically covers posting to social media.

The private picture policy starts once the picture is finished. The policy ends when:

- The private time duration has been completed and no refreshes were made.
- The client has posted the picture on social media, revoking its private status.
- The client has been blacklisted and is no longer being serviced.

If the client revokes private status early, **there are no refunds** for leftover time. Please be sure of how much time you need.

## Automatically Denied Request:

- Cluttered/overly detailed characters
  - Real people
  - Political/controversial topics
